Dana: Health Departments who give up roles in community efforts and those who don't have a good relationship with their county commissioners are missing the opportunity to strengthen their relationship with commissioners, and solidifying their place in the community. Data collection, healthy communities, and lending an ear to those who don't have a voice are unique requirements of a health department. It's important to maintain your role in the community.

Nick: Has anyone been in contact with KDHE or has concerns with aggregate data input to DAISEY being phased out? Is this hearsay or is it warranted? KDHE's response came after the meeting: Rachel Sisson (Director of Bureau of Family Health) responded that DAISEY aggregate reporting is "not being phased out at all! This is in place to support MCH orgs/partners."
