Approval of Agenda

Terry moved to approve the agenda, and Jason seconded. The agenda was approved unanimously.



Approval of October Minutes

Dana moved to approve the October minutes, and Lynnette seconded. The minutes were approved unanimously.

2019 Policy Statement

KALHD members reviewed the draft 2019 policy statement, and suggested a couple minor changes to correct grammar errors. Nick motioned to approve the statement, and Terry seconded. The policy statement was approved with typo corrections.

A final version will be emailed to members, along with a letter template. Legislators will receive a copy in their KALHD Christmas cards in December.

2019 Annual Budget

Michelle reviewed the budget document with members. Highlights of the discussion:

- At the time of the meeting, the Core Support (\$70,000 annually) and PHEP (\$68,000 annually) grant status are unknown. *In December, KDHE informed KALHD that that they will not be renewing KALHD's contract in the PHEP program for 2019-2020.*
- PHPP and PHNCI grants ended in FY2018, so all of those funded needed to be spent down before the end of those grants.
- KIPHS grant was extended to March 2019. We will need to spend the remaining balance by the end
 of March.
- KALHD returned all but \$4700 to KHF's Event Management grant. The remaining funds will be used to support meetings such as KHM and PHSG.

Even with significant reductions to the 2019 budget, the ending balance is just over \$40,000. Jennifer inquired about raising dues. Dan, Jennifer, Karla, and Nick will work together to research the idea of raising dues for 2020.

Jason motioned to accept the 2019 budget document, and Terry seconded. The motion passed unanimously.

October Financial Report

Dan presented the monthly financial report for October 2018. Nick motioned to approve the report, and it was seconded by Karla. The motion passed unanimously.

Our goal, regarding SDOH, is to identify what everyone is doing, what concerns there are, what partnerships are important, and what duplications exist.

FPHS Subcommittee & Pathfinder Projects

Pathfinder Projects:

Area 1: Demonstrate the role, activities and value of public health in ensuring safe and healthy communities through advocacy efforts.

- Pathfinder Project #1: Compile and organize local community health assessments (CHAs) and community health improvement plans (CHIPs) to identify priorities and drive action.
- Pathfinder Project #2: Develop a variety of resources to support talking about public health to a variety of Audiences.
- Pathfinder Project #3: Target the "need to know more" LHDs around these issues to make connections with them and understand their perspective (not to convince)

Area 2: Explore and implement new governance and service delivery models.

Pathfinder Project #4: KALHD Workshop/s

Area 3: Further explore fiscal policy recommendations to ensure that the costs of foundational public health services are covered in every community.

Pathfinder Project #5: Finalize the Future of Public Health in Kansas Fiscal Assessment

Area 4: Develop a legal framework to support public health modernization in Kansas.

- Pathfinder Project #6: Follow-up on completion of the PHNCI Policy and Legal report and ensure it's reviewed and vetted by KALHD stakeholders.
- Pathfinder Project #7: Education (for LHDs) on advocacy and lobbying and how to drive policychange at annual and/or MYM, etc.

Area 5: Explore and implement performance measures and accountability structures for public health in Kansas.



 Pathfinder Project #8: ID a "core set" or "lead set" of FPHS Performance Measures, communicate those and ID performance against those measures statewide.

We will track the progress of these projects and report out at board meetings. Please note these are the initial pathfinder projects, which we hope will lead to other projects in the future.

After this meeting adjourns, board members will reconvene upstairs to discuss the plan for strategic planning and priority-setting in January.

Michelle: Please add an agenda item for spring board meeting to discuss how to formalize the structure for the FPHS subcommittee and bylaws revision.


Advocacy Goals and Strategies for 2019 - Michelle

Members had an initial conversation about KALHD's strategies for 2019, given the new incoming administration who is more supportive of Public Health.

Michelle's 2019 legislative session priority issues are engagement, and relationship building. Secondary to that, should be to have a clear and consistent shortlist of public health critical issues. It's important that members all agree on this list, and communicate public health issues to legislators using consistent language. It would be beneficial to consult with transition team member about the importance of strengthening our relationship and increasing our partnership opportunities with KDHE. KALHD should be recognized as a key stakeholder in those decisions.

Members agreed to Michelle's assessment. Michelle discussed ways that members can "expand their base" using power mapping and provided tips on having more productive one-on-one conversations.

As of today, January 11, 2019, the committee list still shows 2018 session legislators.

Members discussed reviving the regular meetings with KALHD, KPHA and KHDE Secretary and discussed the differences among advisory committees, blue ribbon panels, taskforces, State Board of Health statewide groups and explored ideas for creating a group to help advocate for KALHD members. Michelle suggested tying this to the overall goal of increasing engagement with KDHE and modernization efforts.

Michelle asked members to think about the tools members need KALHD to provide to help in relationship building and continue thinking about whether or not we should ask for a taskforce or advisory group. Deadline for this is the week of November 26.

Lindsay proposed Michelle and Heather put together a policy committee, with an invitation to KALHD membership and continue this conversation on a call. Board members can hold key informant interviews with past BOH and give feedback to Michelle within the next 30 days. KALHD will send out the 2019 policy statement, draft letter and link to the Kansas Legislature website. Reminder that our goal is 80% contact rate.
