- KALHD PHEP Contract. KALHD has a contract with KDHE for participation in the PHEP program.
 The current contract runs through June 2018 and is in the final extension year allowed under the
 current contract. In December, KDHE notified KALHD of their intent to not renew
 KALHD's contract for the 2019-2020 PHEP program year.

Monthly Financial Report

Dan provided a brief summary of the November and December financial reports. Members discussed ideas for addressing budget concerns in 2019 and beyond.

Overview of Board Processes and Responsibilities and Review of Materials – Michelle Ponce Michelle provided an overview of board member responsibilities and handouts provided in the board members' notebooks.

KAC Update – Nick Baldetti

- Randal Allen's contract was not renewed. Dennis Kriesel is the interim Executive Director.
- The next KAC board meeting is January 27.
- Jay Hall is the new KAC Legal Counsel.
- 2019 KAC Conference planning is underway and members are asking for breakout topics.
- The board discussed whether KALHD will pay for a vendor expo booth in 2019. Heather will hold off on the booth registration until further notice.

Review of Budget and Transition Planning – Jennifer Green

Members discussed Michelle's departure how the hiring process will work. So far, two individuals have contacted Michelle and are interested in applying for the Executive Director position. Members decided not to post the vacancy to online job boards, and will recruit internally and via word of mouth. Jennifer will accept applications through January 25. Interviews will take place on February 4. Jennifer will also send a brief survey to all KALHD members. The survey data will be used to develop the interview questions.

Budget Review: Members discussed the following cost cutting measures: going to a virtual office, potential salary savings based on the incoming Executive Director's salary, and decreasing the KAC administrative services contract amount. Members discussed options for increasing revenue, including increasing dues and midyear meeting registration fees; seeking grant funding; and potential contract services that could be provided to other small organizations.

Heather will draft various scenarios of dues increases and will send to the executive board. The board decided to continue this discussion at the next KALHD board meeting. KALHD will provide a packet of budget ideas during the KALHD district meetings.
