This letter provides the Kansas Association of Local Health Department's (KALHD's) written concurrence, on behalf of member local health departments, for the proposed use of the non-earmarked cooperative agreement funds as described in the Kansas Project Budget and Kansas Work Plan Budget Year 2019-2020.

The process leading up to this letter of support is outlined in the following boards:

- On April 8, 2019 KDHE staff distributed the draft local and regional public health work plans to KALHD members.
- On April 11, 2019 KALHD members and staff participated with KDHE Public Health Emergency Preparedness (PHEP) to discuss the draft work plans and to provide feedback.
- Between April 11 and April 14, 2019 additional feedback and concerns were shared between local health departments, KALHD staff, and PHEP staff.
- On April 15, 2019 KDHE staff distributed the revised, final local and regional work plans to KALHD members.
- On April 16, 2019 the KALHD Board of Directors voted to support the local and regional work plans and grant application.

KALHD is the statewide membership organization that currently represents 93 of the 100 local health departments in Kansas. The non-member local health departments, by county, are: Chautauqua, Cherokee, Finney, Hamilton, Labette, Montgomery, and Republic.
