## KDHE Updates (Cristi Cain)

- KGMS has a deep bug. KDHE is working to fix it, and will provide updates and information later this week.
- LPH staffing updates
  - New public health nurse starting October 7.
  - Katie received a promotion; her position will be posted soon.
  - Tyson will be on parental leave any day.
- MAPP training will be held in Garden City on September 18-19. NACCHO staff will be administering this training session.
- Workforce development forum will be held September 23 (pre-conference with KPHA) at the Topeka Ramada. There will be presenters from deBeaumont Foundation.
- Behavioral Health Community Planning Day will be held September 30 at the Cyrus Hotel in Topeka.
- Future KDHE regional meeting topics include vaping, and climate change & intersection with public health. Send your topic ideas to Cristi.
- Opioid funding is coming soon. This funding will target 6 high-need communities. Cristi will send out more info soon. Opening funding will also be available.
- Legislation-Top initiatives are:
  - State Formula Funding Increase this initiative will be driven by KALHD. Members discussed the various options for amending this statute. This topic will be added to the October board meeting.
  - School inspections this initiative will be driven by KALHD, and members discussed having this statute removed. This conversation led to KALHD members asking to have the KALHD legislative policy statement edited to include KALHD opposing unfunded mandates. Dennis asked members with existing charter resolutions to email him their language. This topic will be added to the October board meeting.

The impetus for the position is to bring KAC more strength in advocacy and lobbying efforts in effectively representing Kansas Counties in the Legislature.

The KAC annual conference will be held in Wichita at Century II this year from November 12-14. The KALHD annual meeting will coincide accordingly.
