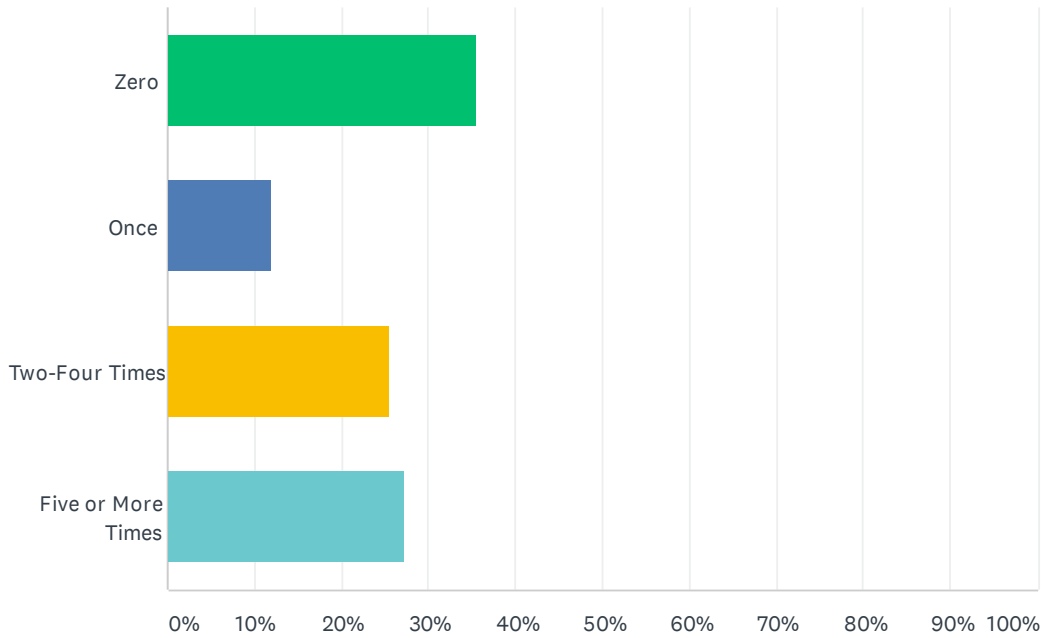

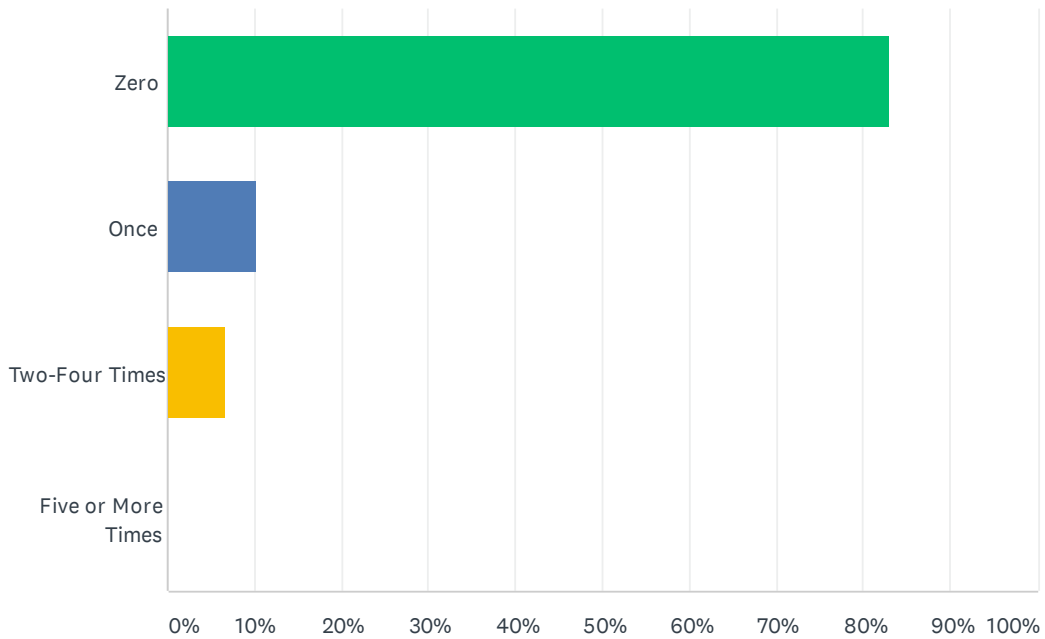

Q2 How many times has any of your staff been injured or physically confronted by persons motivated by COVID-19 related issues?

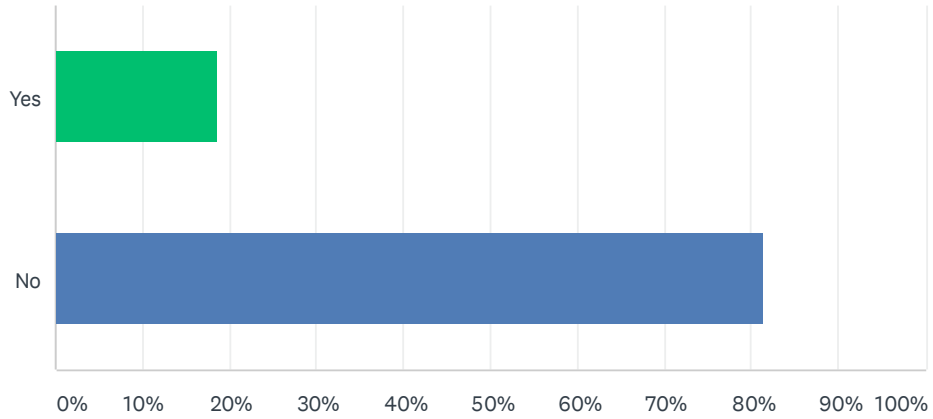

Q3 Have any of these threats to you or your staff been reported to law enforcement?

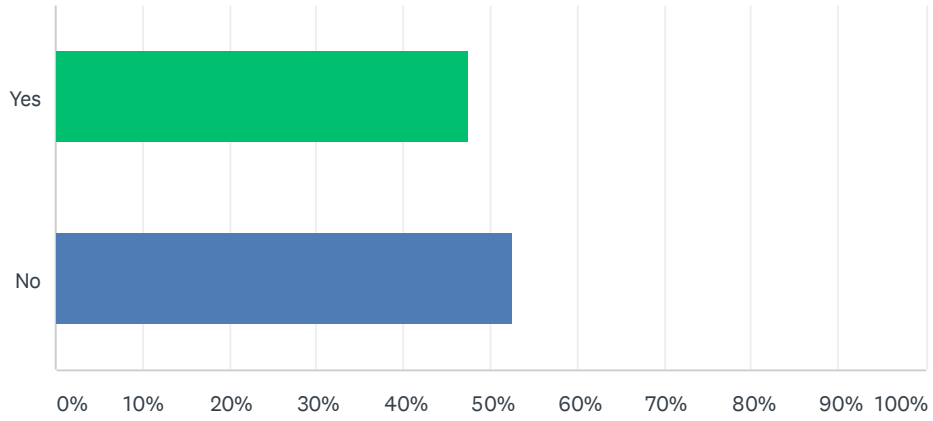

Q4 Have any of these threats to you or your staff been reported to your board of county commissioners?

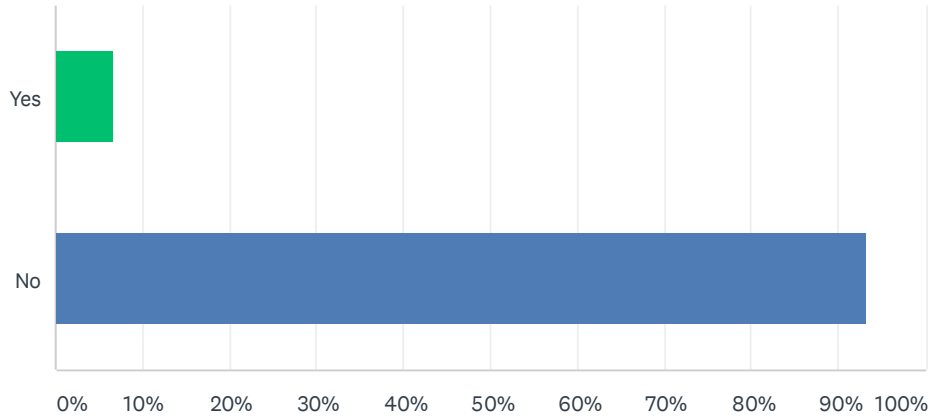
