### **KIP Project Updates**

### 1. White Paper Released Yesterday

KALHD's white paper on vaccine hesitancy was released yesterday on the link only webpage for local health departments. Overall, the white paper was a success and we have had a lot of great feedback on vaccine hesitancy from health departments and partner organizations. Check out the paper when you get a chance.

I am working with KAC on their KCCA conference coming up in April. They are hopeful to have a general session on history of vaccines and a panel on misinformation.
