



Attendee Demographics

Mid-Year Meeting (MYM) occurred June 27-29, 2022 (June 27th was Data Day, a pre-conference event held at no cost to attendees with expenses refunded by Wichita State University).

Attendee Highlights:

- 113 people registered to attend at least one day, including Data Day (including presenters)
 - 83 from LHDs
 - 56 different departments
 - 16 from KDHE
 - 6 from WSU
- Not including Data Day-only attendees, we had **98 registered** for at least one day of the main 2022 MYM








