## Attendee Demographics

Mid-Year Meeting (MYM) occurred June 26-28, 2023 (June 26<sup>th</sup> was Data Day, a pre-conference event held at no cost to attendees and primarily managed by Wichita State University; KALHD handled name badges, sign-in sheets, and nurse continuing education credits for the event).

### Attendee Highlights:

- 121 people registered to attend at least one day, including Data Day (includes presenters)
  - 85 from LHDs
    - 59 different departments
  - 20 from KDHE
  - 7 from WSU
- Not including Data Day-only attendees, we had **112 registered** for at least one day of the main 2023 MYM
- Data Day (June 26, 2023)
  - 68 registered
  - 57 attendees signed in
- Day 1 (June 27, 2023)
  - 109 registered
  - 99 attendees signed in
- Day 2 (June 28, 2023)
  - 101 registered
  - 85 attendees signed in
- 51 attendees requested and received CNE certificates

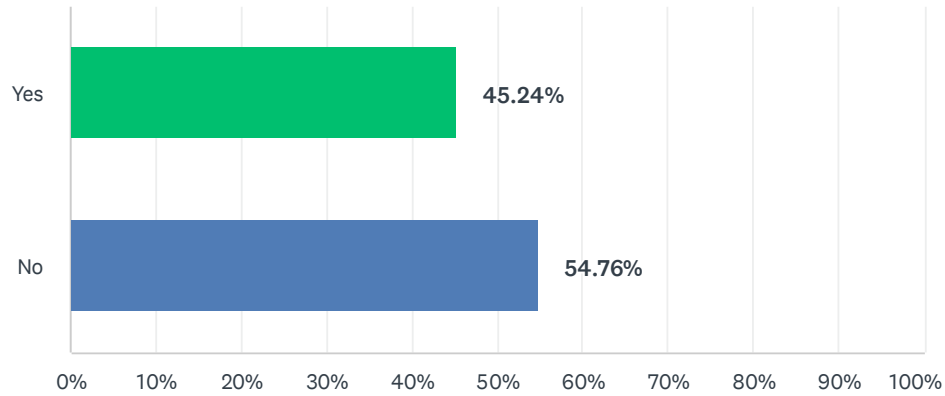

### Q3 Did you attend (in whole or in part) Data Day of the KALHD MYM: Monday, June 26, 2023?

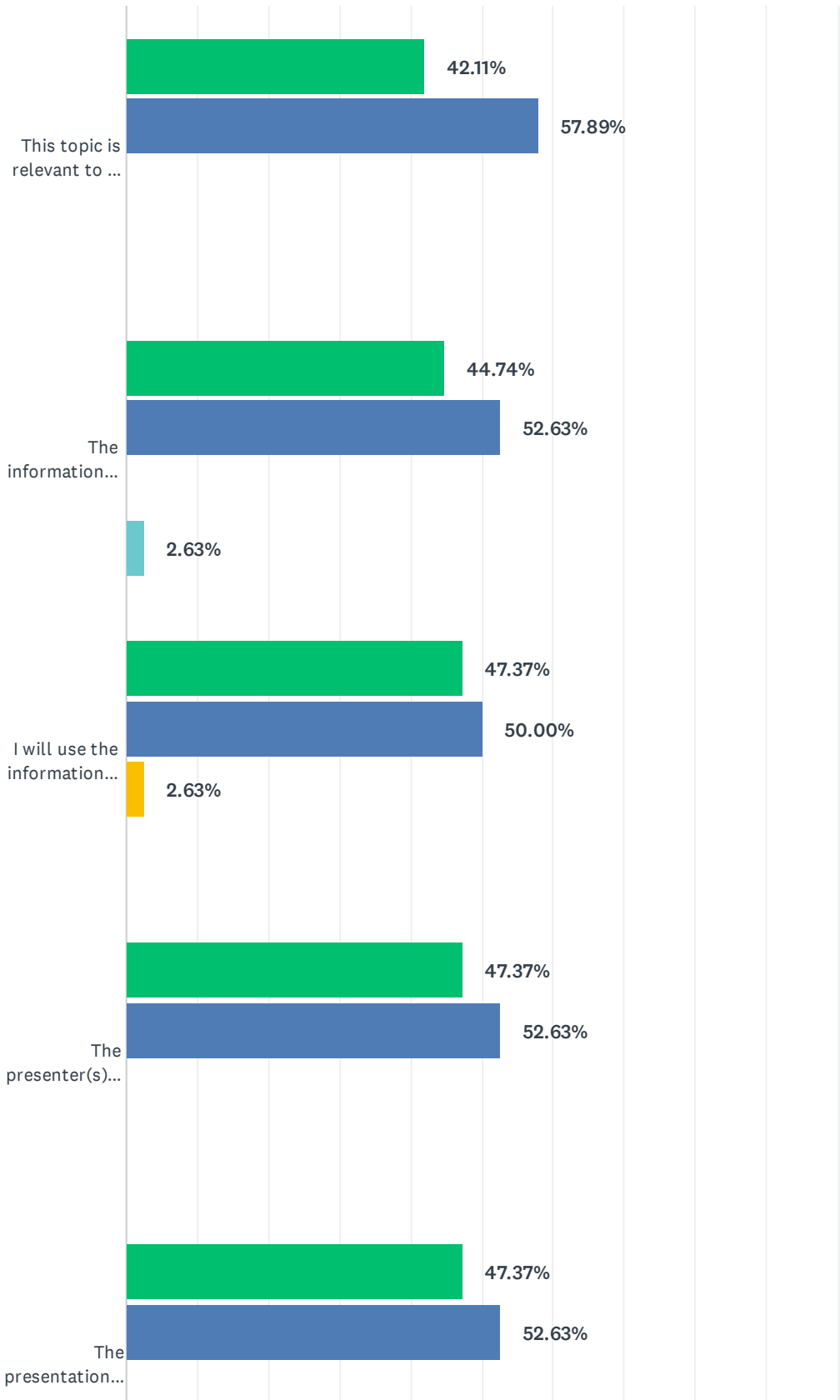

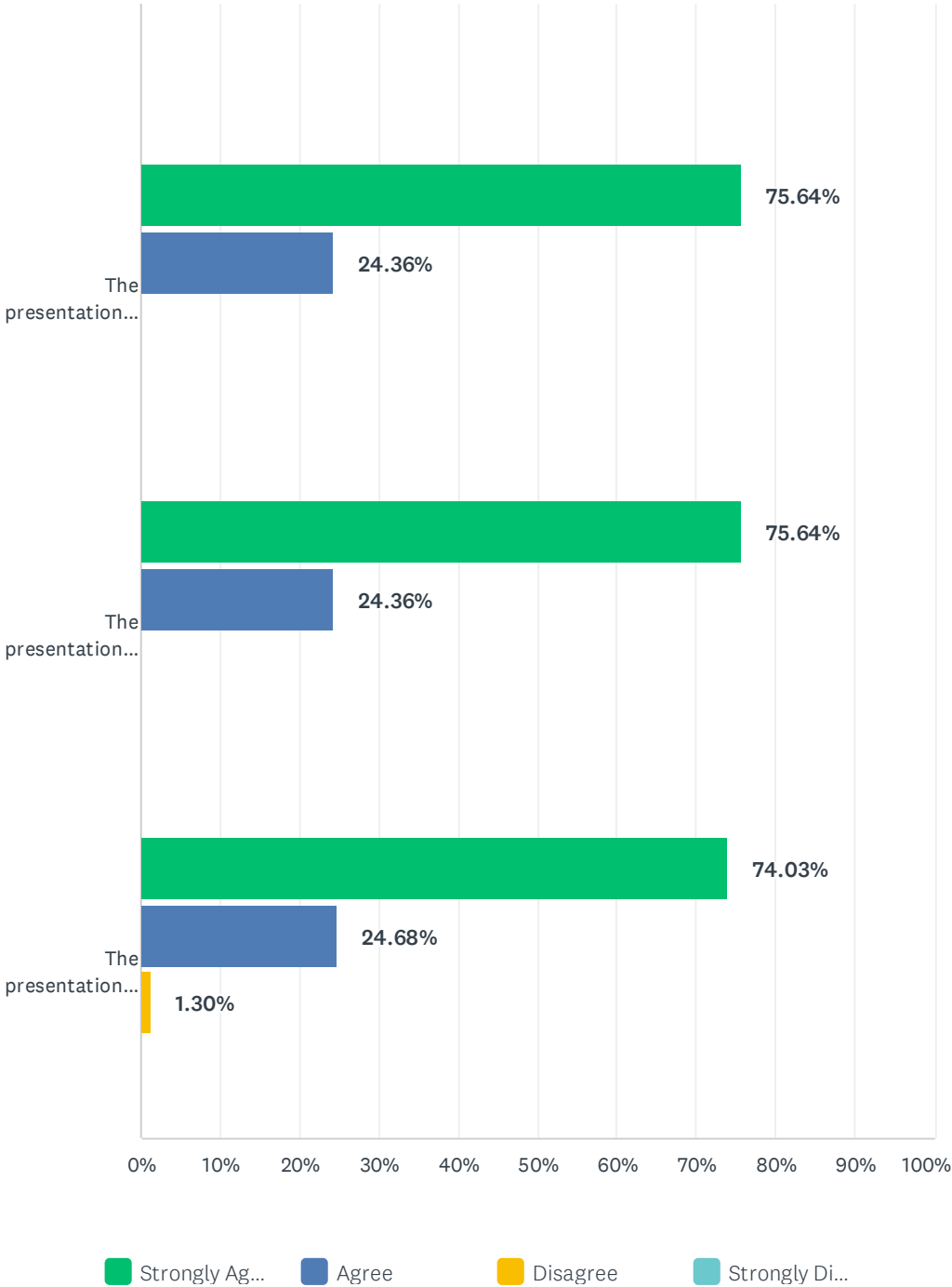


Q10 What Powers Do They Have?

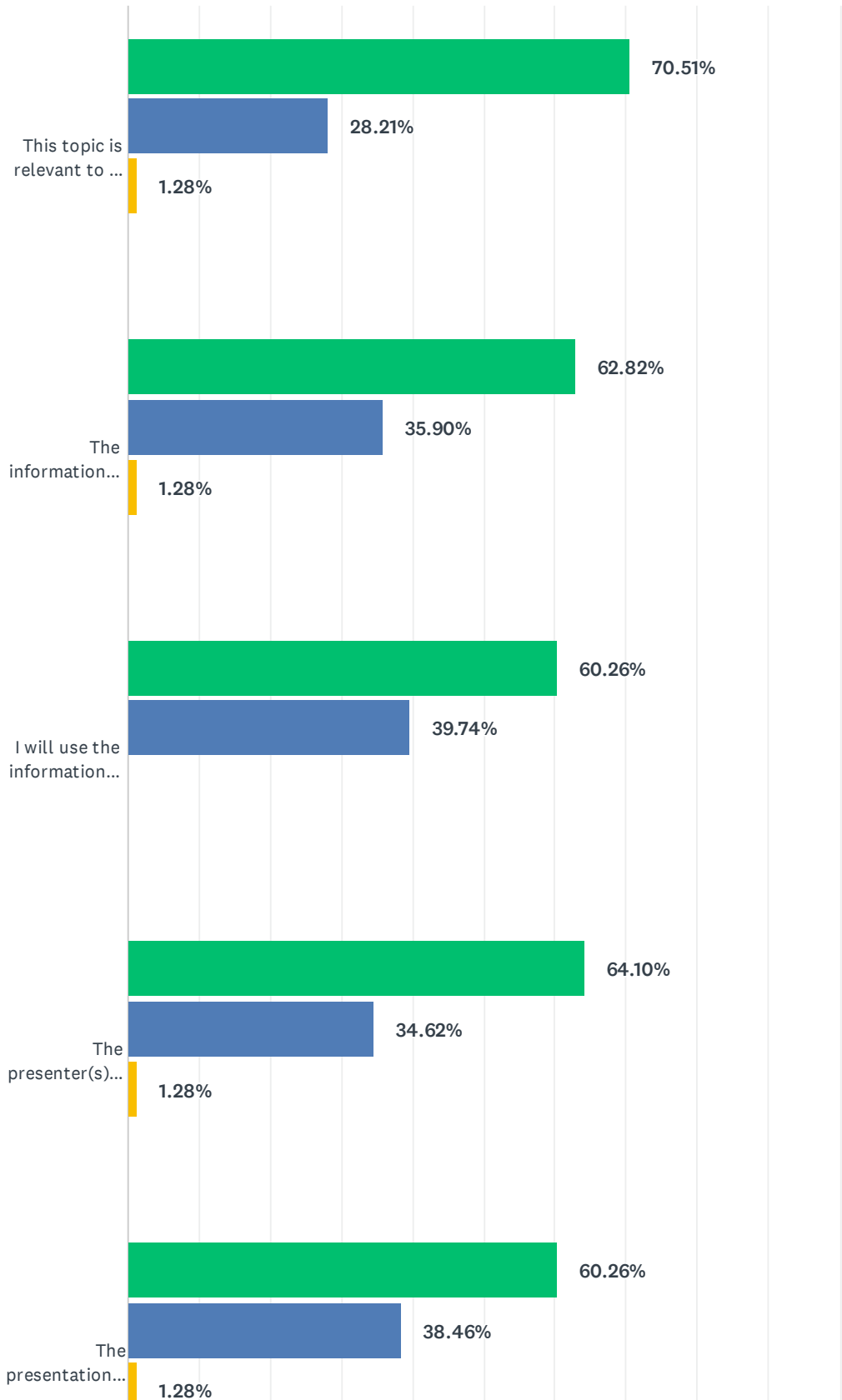

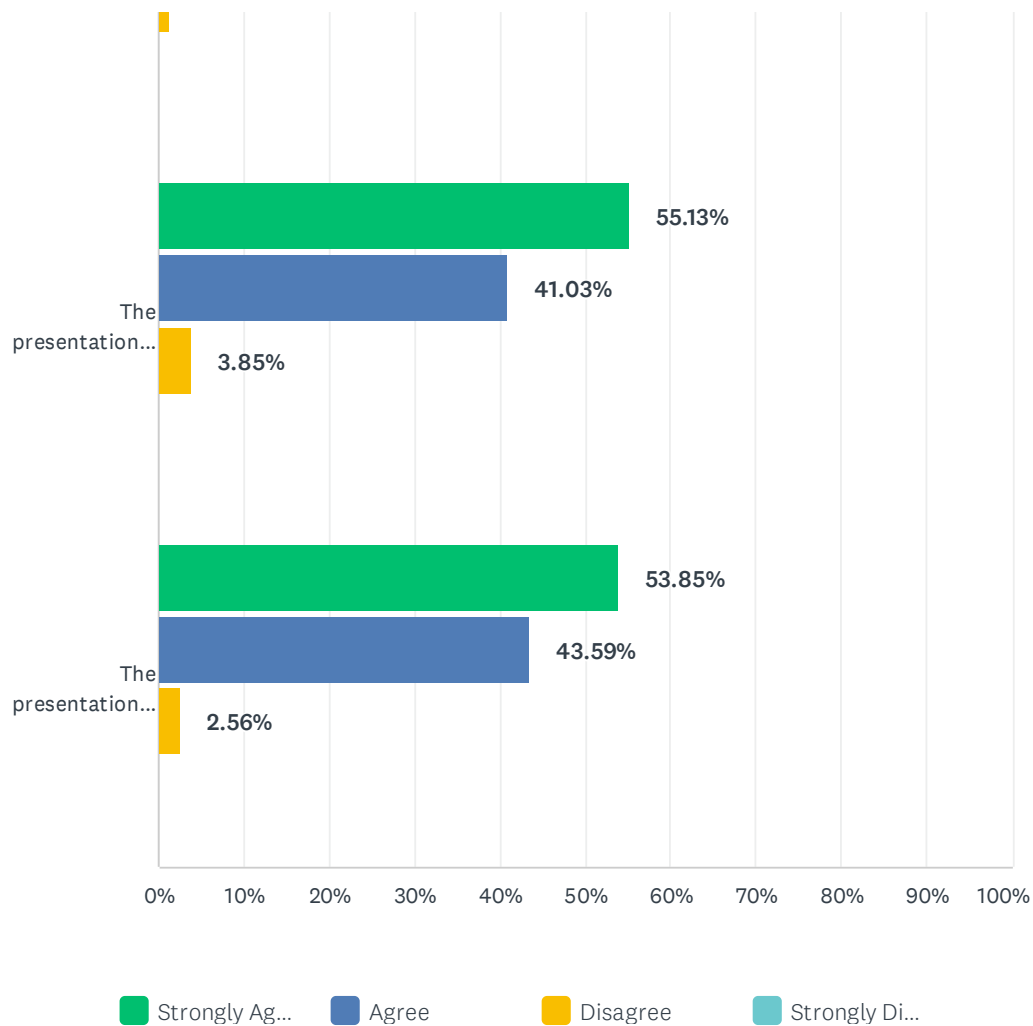


Q13 CDC Workforce Development Grant: What You Need to Know

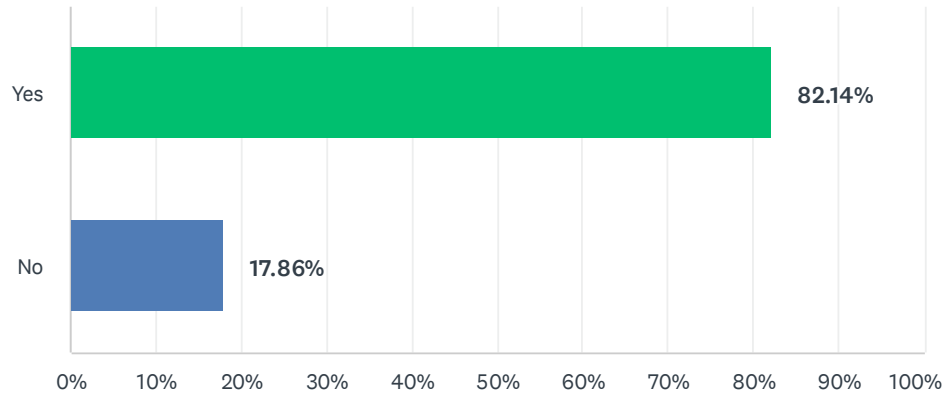

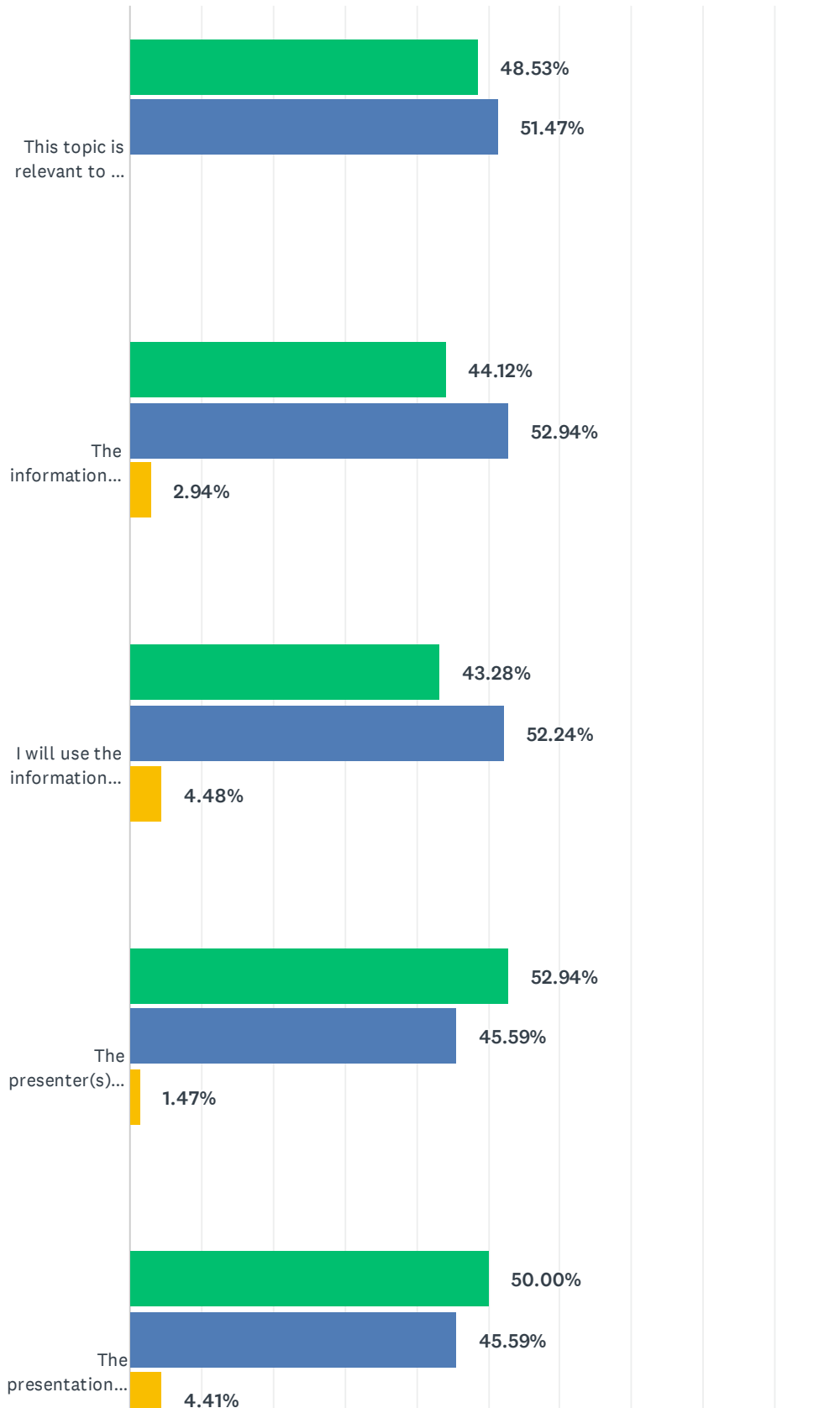

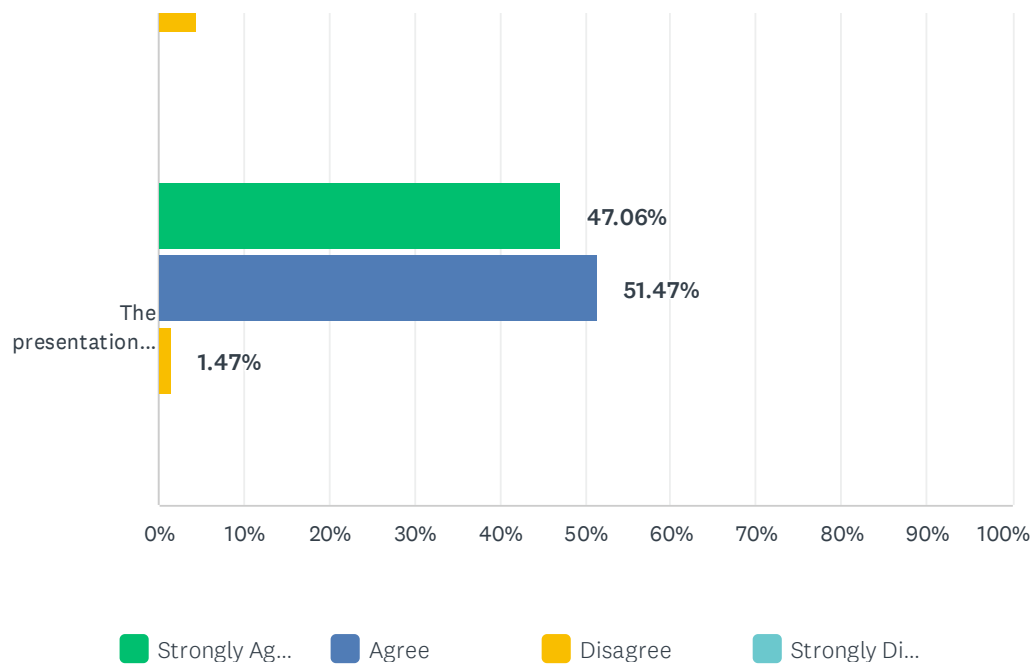


## Q19 2023 State Formula Survey Results

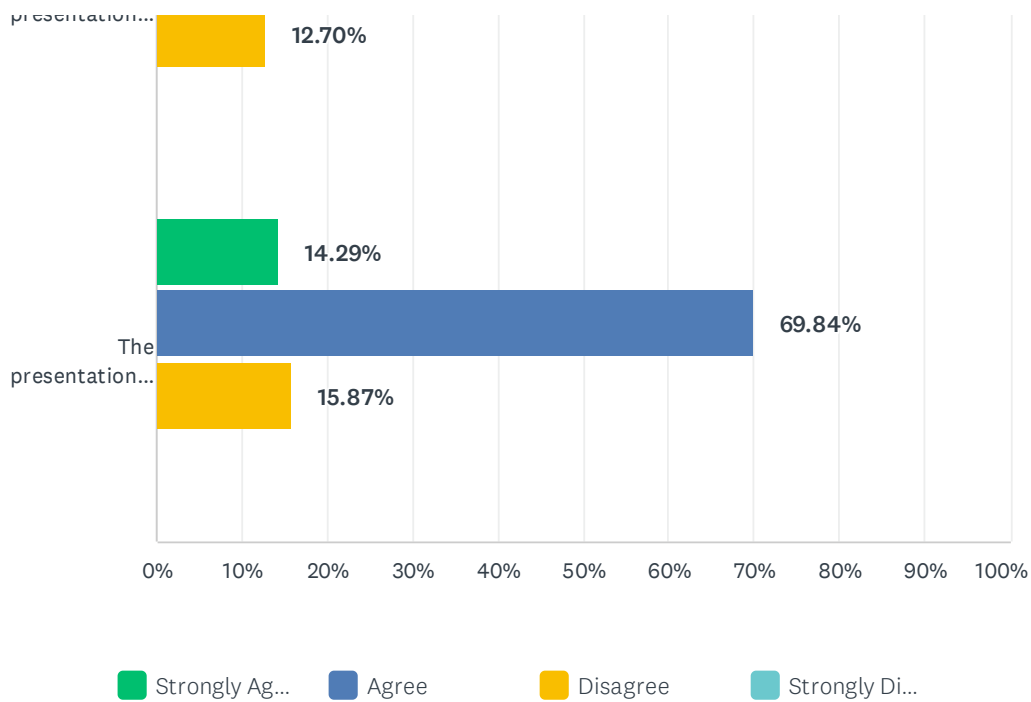
